Universe DREAMS Nested cohort: A nested cohort of 800 AGYW will be followed prospectively at three time points over the two-year study period - baseline, 12 months and 24 months - at points closest aligned with periods before, during and after DREAMS implementation. In ACDIS cohorts of 400 girls aged 13-17 years and 400 young women aged 14-24 years will undergo informed consent, recruited undergo a baseline questionnaire and provide dried blood spot (DBS) sample for HSV2 and for the HIV testing, and then reviewed annually for the next two years. Multilevel HIV Prevention: Participants were randomly selected from a southern part of AHRI surveillance area, stratified by age, sex and week-block. A target sample size was 2500 males aged 13-35 and 500 females aged 24-29 years

Sampling Procedure

The type of sample and sample design used to select the survey respondents to represent the population. May include reference to the target sample size and the sampling fraction

DREAMS: Adolescent girls and young women aged 13-24 years who were residents in the demographic surveillance area of the Africa Health Research Institute. A total of 3013 participants were randomly selected to obtain a target sample size of 800 after 2 years of follow-up, allowing for 40% non-contact/loss-to-follow-up. Sampling was stratified by age group and area (week-blocks).

Multilevel: Participants were randomly selected from a southern part of AHRI surveillance area, stratified by age, sex and week-block. A target sample size was 2500 males aged 13-35 and 500 females aged 24-29 years.

The identification will not be revealed to any other person not included in the Data Access Agreement.
6. The Lead Researcher will implement security measures to prevent unauthorized access to licensed microdata acquired from the Data Archive. The microdata must be destroyed upon the completion of this research, unless the Data Archive obtains satisfactory guarantee that the data can be secured and provides written authorization to the Receiving Organization to retain them. Destruction of the microdata will be confirmed in writing by the Lead Researcher to the Data Archive.
7. Any books, articles, conference papers, theses, dissertations, reports, or other publications that employ data obtained from the Data Archive will cite the source of data in accordance with the citation requirement provided with the dataset.
8. An electronic copy of all reports and publications based on the requested data will be sent to the Data Archive.
9. The original collector of the data, the Data Archive, and the relevant funding agencies bear no responsibility for use of the data or for interpretations or inferences based upon such uses.
10. This agreement will come into force on the date that approval is given for access to the restricted dataset and remain in force until the completion date of the project or an earlier date if the project is completed ahead of time.
11. If there are any changes to the project specification, security arrangements, personnel or organization detailed in this application form, it is the responsibility of the Lead Researcher to seek the agreement of the Data Archive to these changes.
